In this regard, the point wise reply is as under :-

**Point 1 to 2 :-** Import of Non-tobacco and Non-Nicotine Electronic vaping devices and Electric Cigarette alone are not banned or restricted.

**Point 3 :-** Non Tobacco and Non Nicotine liquids, liquids, liquids that do not contains nicotine and contain PG, VG and flavours are not banned and not on the restricted import list with the Boards.

**Point 4 :-** Nicotine liquid with various strengths including that of 0.3mg/ml, 3mg/ml are not banned and not on the restricted import list with the Board.

**Point 5 :-** Nicotine liquid with various strengths including that of 0.6mg/ml, 6mg/ml are not banned and not on the restricted import list with the Board.

**Point 6 :-** Nicotine liquid with various strengths including that of 1.2mg/ml, 1.2mg/ml are not banned and not on the restricted import list with the Board.

**Point 7: -** Nicotine liquid with various strengths including that of 1.8mg/ml, 1.8mg/ml are not banned and not on the restricted import list with the Board.

**Point 8:-** Import of e-Cigarette & e-liquid is governed by the existing EXIM policy, DGFT Circular, Ministry of Health advisories/Rules.

**Point 10 & 11 : -**At present, no such notification has been provided to ban on importation of accessories for Non Tobacco and Non Nicotine E-Cigarette by CBEC.

**Point 12-17:** -The information asked is related to policy issue. The policy is governed by the existing EXIM policy, DGFT Circular and rules / notification / instruction etc. issued by Ministry of Health

In case you are not satisfied with the information supplied, you may prefer an appeal before the First Appellate Authority, ACC-Import Commissionerate, New Custom House, New Delhi-110037 within 30 days of the receipt of this letter under Section 19(1) of the RTI Act, 2005.
